This will be my last chairman's report as my term comes to an end in January 2015 and I will not be seeking re-appointment. I have served on the foundation for the past ten years and it has been a rewarding experience.

As I look back over those years, I have seen the Foundation grow. The Foundation was able to support many leadership grants for both students and staff in the division. Initiatives like sending students to the Mustard Seed to experience firsthand what it is like to be homeless; sending students and staff to confer-

ences; funding musicals, service programs and retreats. The directors had opportunity to hear students and staff tell of their experiences and how they would share this with others in their schools. In closing, it has been a pleasure and an honor to work with everyone on the Foundation, the school board Trustees, and staff at the board office. Their willingness to help and their friendliness made being a Foundation director extremely rewarding.

*NEW School Project Enhancement Grant

The Foundation has established a School Project Enhancement Grant to provide Medicine Hat Catholic Schools with the opportunity to apply for funding for their own unique priorities.

Objectives:

- Each year the Foundation may award a grant to a division school up to a max of \$5,000
- All projects and programs must be compatible with the objectives of the Foundation
- The objective of the School Project Enhancement Grant is to enhance school programs/projects/ initiatives that are not funded by Alberta Education

Priority will be given to:

- Projects that demonstrate innovative practices, initiative and sustainability
- Projects that incorporate community partnerships (other schools, parent organizations, local parishes and community groups)
- Projects that can demonstrate direct impact on students
- Projects which assist students, teachers and staff achieve a new level of excellence

SCHOLARSHIPS

Scholarships can be established to support students as they venture out into post-secondary education. Criteria can be specified to target particular areas of interest or in memory of a loved one. Tax receipts available for donations.

Archie MacPhail Memorial Scholarship (\$500) - available to Grade 10-12 students to promote spiritual growth, Christian lifestyle, and development of religious leadership skills.

Education Foundation Servant Leadership Scholarship (\$500) - available to all grades at all schools to a student who demonstrates a servant heart and is active in making a positive difference in the world.

James Michael (Mickey) Lynch Memorial Scholarship (\$200) -

available to a Grade 12 student who was also a graduate of St. Louis School. Chosen based on demonstrated skills in English grammar and must be registered in post-secondary education program.

Joe Stroh Memorial Scholarship (\$500) - available to a Grade 12 student selected by McCoy staff for outstanding citizenship and service within the school and church community.

Mook Giesinger Awards - Diligence awards given to students at St. Louis School who work hard, show improvement, and exhibit an excellent attitude and effort. \$25/each

Pat Cullen Memorial Scholarship - Math awards available to St. Mary's students. \$200 each to Gr. 7,8,9 highest achievement; \$100 each Gr. 7,8,9 second highest achievement.

Sister Joan Burns Memorial Scholarship - Religious Studies Awards available to St. Mary's students. \$200 each Gr. 7,8,9 highest achievement; \$100 each Gr. 7,8,9 second highest achievement.

Stan Gill Memorial Scholarship (\$500) - available to Grade 12 student with highest mark in Biology 20 & 30 combined.

Tom Anderson Memorial Scholarship (\$500) - available to a Grade 12 student who is planning to pursue a career in Business and is registered in business related post-secondary program.

Winter Games Legacy Scholarship (2 x \$500) - Available to a Grade 12 student. Candidate must have displayed leadership in their chosen sport and be enrolled in a post-secondary program.

GRANTS AWARDED

Grade 6 Retreat—École St. Thomas - \$500

Funds used to transport students to Camp McCoy to participate in activities to develop their leadership skills and learn more about their faith.





WE Day (Monsignor McCoy & Notre Dame Academy) - \$647.50 each

Funds to transport students to Calgary to attend day of celebration and inspiration with a focus on young people leading local and global change.

SPICE Conference - \$3,000—'Shared Purpose in Catholic Education' Conference—bringing together Catholic school communities to collaborate and explore current issues in education. Funds used to cover cost of registration.

Science Program Enhancements & Basketball Hoop Maintenance—St. Michael's BI—\$1350

Division Spring Sing (Elementary Schools) - \$400 Choral workshop and concert. Funds used to cover the cost of facility rental and transportation of students.

Little Mermaid Musical (St. Mary's) - \$1000 Grant used to support the musical production by covering cost of printing and transportation to and from event location.





Worldstrides Heritage Festival (St. Mary's) - \$3,000 Cost of transporting students to Vancouver for competition and workshops.


Breakfast Program (St. Louis) - \$100


